GOOCHLAND COUNTY PARKS AND RECREATION WALL OF FAME CONSTITUTION

PURPOSE

The Goochland County Parks & Recreation Wall of Fame award is intended to honor a Goochland county resident with a longstanding humanitarian commitment to addressing community needs. This commitment will have been demonstrated through the development of personal contributions that go well beyond the traditional service role of the average citizen and reach individuals whose lives may not have been as fully enriched. This award brings to light community service as an important element of the humanitarian mission, and singles out individuals who serve as examples of social responsiveness on behalf of Goochland County. The award recipient must have demonstrated broad-based, commitment to community service as reflected in a variety of programs and initiatives which are responsive to community and social needs and which show evidence of a true partnership with the community. The location of the actual Wall of Fame will be resided in the main complex for Parks and Recreation.

SELECTION COMMITTEE

The Wall of Fame committee shall be comprised of the members of the Goochland Parks and Recreation Advisory Commission.

CRITERIA FOR SELECTION OF INDUCTEES

- A. The nominee may have participated in innovative program, athletics, recreation or academic socialization which contributed significantly to Goochland County Parks and Recreation.
- B. The nominee must have contributed substantial service for a minimum of five years and made a lasting impact to the stakeholders of Goochland County.
- C. A nominee must receive a majority vote of the quorum from the Goochland Parks and Recreation Advisory Commission.

METHOD OF SELECTION

- A. The committee shall accept nominations during the year with a submission deadline of December 31st.
- B. Give a brief description of the candidate's achievements, contributions, including any form of special recognition, awards, honors, prizes and appointments

- C. The board will select inductee(s) by January 31st of the next year
- D. Copies of the information on each nominee shall be sent to the board members prior to the selection meeting.
- E. Each committee member shall have one vote. If a board member is absent, his/her vote may be made by written proxy before the meeting. The proxy must be received by Parks and Recreation Director or designee by the selection meeting date.
- F. Committee members will be required to abstain in a vote of an immediate family member of his/her candidacy. Members of the immediate family include spouse, parents, parents-in-law, brother, sister, children, step children, grandchildren and grandparents.
- G. The committee will decide on a yearly basis the number of inductees to be honored.
